The side event will present the **working document entitled “Child Rights in the Global Compacts”**. This document for dialogue lays out goals, targets and indicators – in line with the 2030 Agenda for Sustainable Development – through which six key commitments to child rights outlined in the New York Declaration can be operationalised across both global compacts. The Working Document was developed by the **Initiative for Child Rights in the Global Compacts** driven by a civil society-led steering committee, which is co-convened by Save the Children and Terre des Hommes and which comprises experts, multilateral institutions, and non-governmental and philanthropic organisations. The side event will report back from the **Global Conference on Children on the Move** organised in Berlin 12th and 13th June, discuss and advocate for a **strong global strategy** on protecting the rights of children on the move and other children affected by migration.
